"Metalcolour Firesafe Polyester"

consisting of one coat of 8  $\mu$ m polyester/melamine primer and one coat of 32  $\mu$ m polyester topcoat roller, bonded to a steel/aluminium sheet of thickness 0.4 – 1.25 mm.

# **Application/Limitation**

Approved for use as low flame spread surface material, not generating excessive quantities of smoke nor toxic products in fire.

Approved for use on metallic surface (steel/aluminium) with thickness of at least 0.4 mm.


