### **Product description**

"Metalcolour Firesafe Polyester "  
consisting of one coat of 8 µm polyester/melamine primer and one coat of 32 µm polyester topcoat roller,  
bonded to a steel/aluminium sheet of thickness 0.4 – 1.25 mm.

### **Application/Limitation**

Approved for use as low flame spread surface material, not generating excessive quantities of smoke nor toxic products in fire.

Approved for use on metallic surface (steel/aluminium) with thickness of at least 0.4 mm.

Any adhesive used, other than the one used during testing, has to be tested for low flame spread characteristics according to IMO 2010 FTP Code part 5 and to be approved according to the Marine Equipment Directive and bear the Mark of Conformity.

The product satisfies the requirement for maximum calorific value (ref. Solas Chapter II-2, Reg 5.3.2.2) without further testing.

Each product is to be supplied with its manual for installation and use.
